Cape Cod Healthcare launched their 2019 Community Health Needs Assessment process by engaging Health Resources in Action (HRiA), a Boston-based public health research firm, to facilitate a ‘Stakeholder Dialogue’ activity with members of our Health and Human Services Advisory Council.

This meeting broke out into 4 working groups and were given question prompts for discussion to be shared by all participants. The goal of the overall assessment is to gain a greater understanding of the health and social issue facing residents across Barnstable County. The assessment seeks to obtain the perspectives of leaders, providers, residents and stakeholders living and working in Barnstable County. HRiA will incorporate the information collected at our meeting into the final Community Health Needs Assessment report along with information collected through additional stakeholder dialogue events, focus groups, and key informant interview.
